DECLARATION

Article II. Section 3.1 is amended and restated as follows:

3.1 Only RV's belonging to Association members may be stored in the RV lot. A list of owners using the RV storage lot shall be maintained with the Board of Directors at all times. All owners must submit in writing what they have parked in the RV lot. All parked vehicles must be insured. All vehicles must be licensed, if required by state law.
